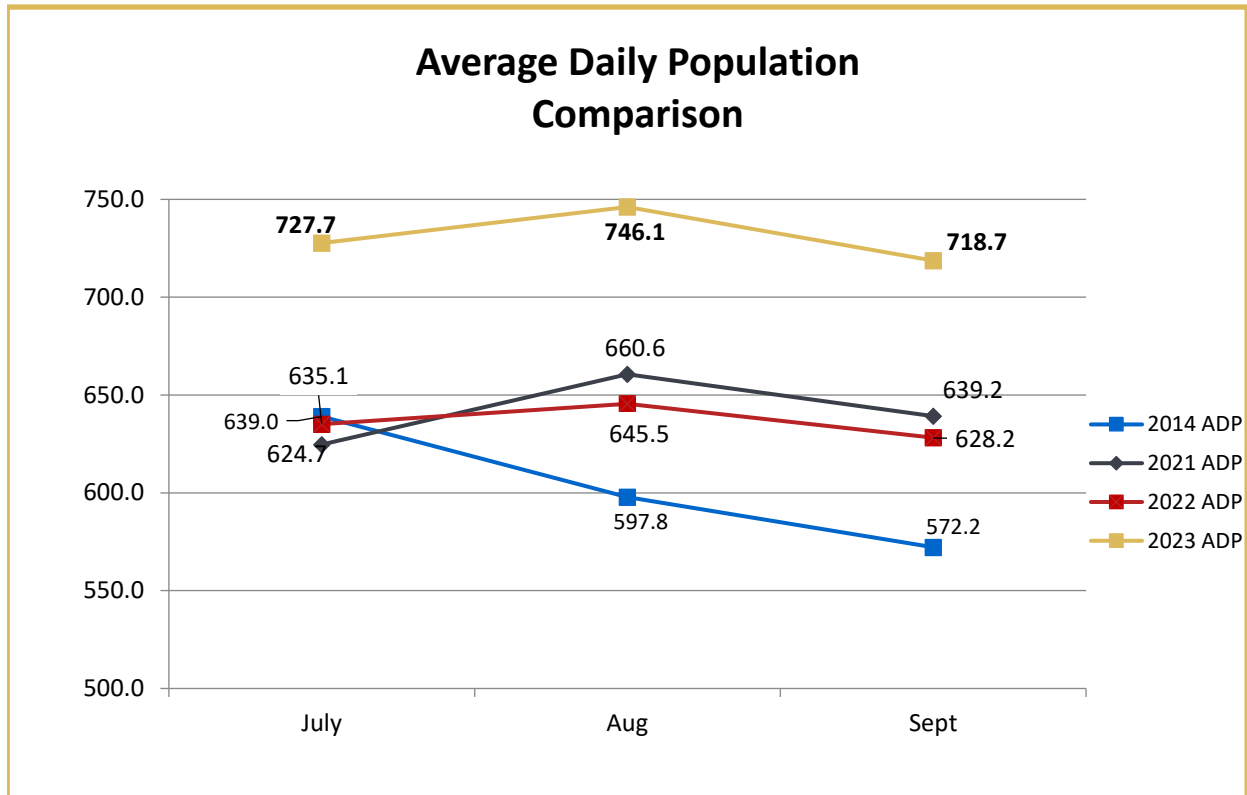

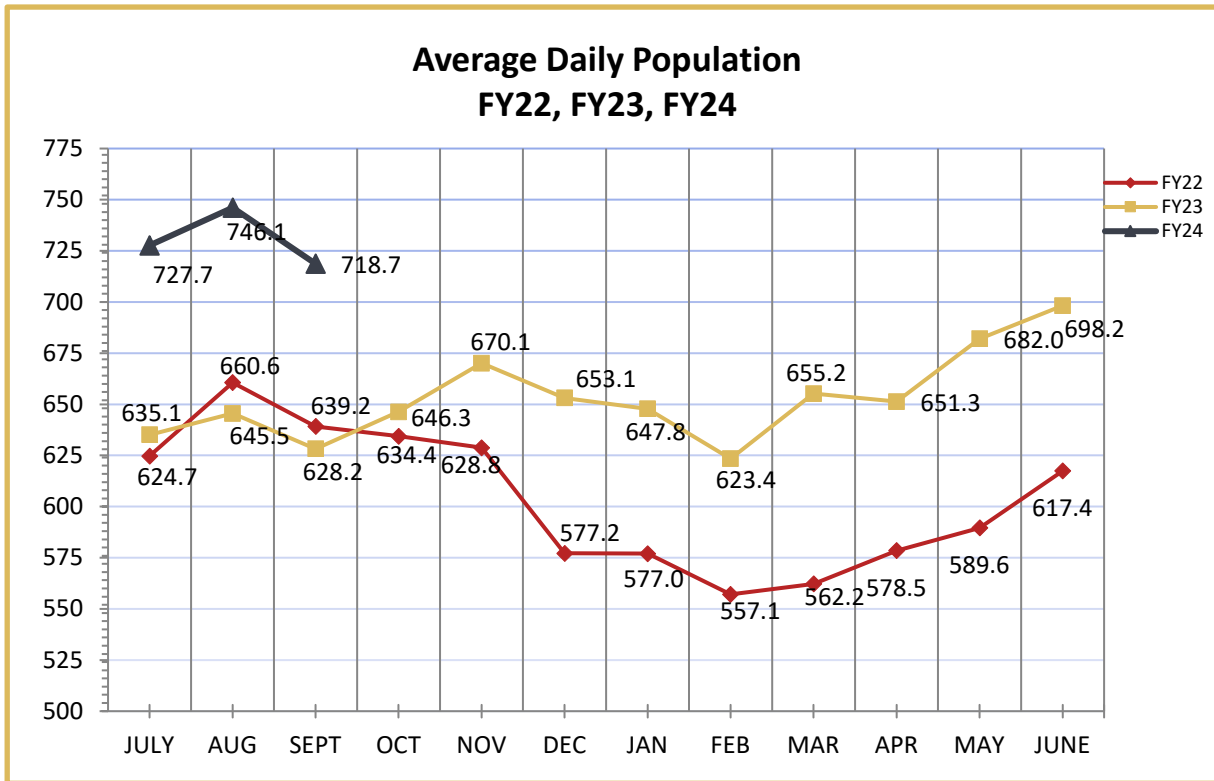
# Average Daily Population



- The average daily population (ADP) for this period of 2023 was 730.8 detainees compared to 636.3 for the same period in 2022. This is a 14.9% increase.
- This period ADP consumed 109.9% of the department's operational capacity of 665.
