Call Meeting to Order

1. 2021 Statewide Tornado Drill Results

Jim reviewed the results of the statewide tornado drill conducted on Wednesday, March 24th, 2021. He compared these results to previous years using the chart below. The 2020 drill was cancelled due to COVID-19 restrictions. The statewide tornado drill is heavily promoted by the National Weather Service. The private sector participant was Lincoln Electric System. New Business

1. Agency Reports

a. Ongoing COVID-19 ‘State of Emergency’ (FEMA DR-4521-NE)

Gina Egenberger, Emergency Response Coordinator, Lincoln-Lancaster County Health Department

COVID-19:

Lancaster County’s COVID risk dial remains at **green** (indicating low risk of spread) and the updated Directed Health Measures removed the mask mandate and allowed businesses to operate at 100% capacity. New COVID-19 cases have been in the single digits for the past 2 weeks. This has been the longest stretch of cases in single digits since the first week of April 2020. The vaccination rate for 16 and older in Lancaster County is just over 62%. The vaccination rate for 45 and older is above 70%. The Health Department is working to improve vaccination rates with individuals 12-45 years old. They encourage individuals who have not received their vaccine to do so in order to protect themselves and others they spend time with.

Personal Protective Equipment (PPE) Distribution:

The state of Nebraska has begun their demobilization of PPE cache. At this time, they have set June 30th, 2021 as their last date of operation. Lancaster County’s Unified Command has not set a time frame for their demobilization process. All agencies who have requested PPE from the Health Department will be notified when there is information to share.

Lincoln-Lancaster County Healthcare Partners (LCHP) Group:

In January 2020, the LCHP developed a Strategic Plan to work together on preparedness at the local level. NE DHHS endorsed LCHP becoming a workgroup under the Southeast Nebraska Healthcare Coalition (SENHCC). With the pandemic, LCHP meetings were suspended and instead LLCHD leadership met weekly with health care facilities on COVID responses. In June 2020, SENHCC went inactive due to lack of fiscal leadership and coordination. Permission to bring the LCHP Group back together has been requested. In the meantime, healthcare facilities are encouraged to reach out with any emergency preparedness needs.

b. LEPC Meeting Schedule Update
