

AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between Mr. Yards and More LLC, 8729 Remi Drive, Lincoln, NE 68526 (hereinafter "Contractor") and the City of Lincoln and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated December 16, 2016 executed under City Executive Order No. 90181, and County Contract C-16-0702, dated December 13, 2016, and executed by the City of Lincoln-Lancaster County Public Building Commission, on December 13, 2016, for Annual Services - Snow & Ice Removal - City and County Facilities, Bid No. 16-181, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is December 16, 2016 through December 15, 2017, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 91324, executed by the City on December 6, 2017, and by County Contract C-17-0897 executed by the County Board on November 21, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 12, 2017, to renew the contract for an additional one (1) year term from December 16, 2017 through December 15, 2018; and

WHEREAS, the Contract was amended by City Executive Order No. 92535, executed by the City on November 29, 2018, and by County Contract C-18-0711 executed by the County Board on November 20, 2018, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 11, 2018, to renew the contract for an additional one (1) year term from December 16, 2018 through December 15, 2019; and

WHEREAS, the Contract was amended by City Executive Order No. 93822, executed by the City on November 27, 2019, and by County Contract C-19-0840 executed by the County Board on November 19, 2019, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 10, 2019, to renew the contract for an additional one (1) year term from December 16, 2019 through December 15, 2020; and

WHEREAS, the parties hereby extend the Contract for a term beginning December 16, 2020 through May 1, 2021; and

WHEREAS, the expenditures for the City of Lincoln for the term of this extension shall not exceed \$25,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$3,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 90181, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby extend the Contract for a term beginning December 16, 2020 through May 1, 2021.
- 2) The expenditures for the City of Lincoln for the term of this extension shall not exceed \$25,000.00 without approval by the City of Lincoln.
- 3) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$3,000.00 without approval by the Public Building Commission.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
