WHEREAS, the Contract was amended by City of Lincoln-Lancaster County Public Building Commission on December 8, 2020, to renew the contract for an additional one (1) year term from December 8, 2020 through December 7, 2021; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning December 8, 2021 through December 7, 2022; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the City of Lincoln-Lancaster County Public Building Commission Contract dated November 12, 2019, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning December 8, 2021 through December 7, 2022.
- 2) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
