

AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between Uribe Refuse Services, Inc., 4600 N. 48th Street, Lincoln, NE 68504 (hereinafter "Contractor") and City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission, (hereinafter "Owners"), for the purpose of amending the Contract dated December 20, 2013, executed under City Resolution No. A-88004, and County Contract C-13-0602, dated December 17, 2013, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 30, 2013, for Annual Requirements - Waste and Recyclable Collection Services, Bid No. 13-304, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is January 1, 2014 through December 31, 2017, with the option to renew for one (1) additional four (4) year term upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 91369, executed by the City on December 19, 2017, and by County Contract C-17-0946 executed by the County Board on December 19, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 12, 2017, to renew the contract for an additional one (1) additional four (4) year term from January 1, 2018 through December 31, 2021; and

WHEREAS, the parties hereby amend the Contract to extend for an additional three (3) month term beginning January 1, 2022 through March 31, 2022; and

WHEREAS, the parties hereby amend the Contract to reflect a 10% price increase effective January 1, 2022, per Attachment A; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$10,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$7,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$5,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Resolution No. A-88004 and County Contract C-13-0602, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby amend the Contract to extend for an additional three (3) month term beginning January 1, 2022 through March 31, 2022.
- 2) The parties hereby amend the Contract to reflect a 10% price increase effective January 1, 2022, per Attachment A.
- 3) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$10,000.00 without approval by the City of Lincoln.
- 4) The expenditures for Lancaster County for the term of this renewal shall not exceed \$7,000.00 without approval by the Lancaster County Board.

- 5) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$5,000.00 without approval by the Public Building Commission.
- 6) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


