This Amendment is hereby entered into by and between Haworth, Inc., One Haworth Center, Holland, MI 49423 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Memorandum of Understanding (MOU) dated March 9, 2020 executed under City Executive Order No. 94133, and County Contract C-20-0132, dated March 17, 2020, and executed by the City of Lincoln-Lancaster County Public Building Commission, on February 11, 2020, for Furniture, Installation and Related Products and Services, MOU068, which is made a part of this amendment by this reference.

WHEREAS, the original term of the MOU is March 17, 2020 through December 31, 2020 with the option to renew for four (4) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 95020, executed by the City on December 1, 2020, and by County Contract C-20-0750 executed by the County Board on December 1, 2020, and executed by the City of Lincoln-Lancaster County Public Building Commission on December 8, 2020, to renew the contract for an additional one (1) year term from January 1, 2021 through December 31, 2021; and

WHEREAS, the parties hereby renew the MOU for an additional one (1) year term beginning January 1, 2022 through December 31, 2022; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$49,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$5,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the MOU under City Executive Order No. 94133 and County Contract C-20-0132, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the MOU for an additional one (1) year term beginning January 1, 2022 through December 31, 2022.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$49,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$5,000.00 without approval by the Public Building Commission.
- 5) All other terms of the MOU, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
