This Amendment is hereby entered into by and between Schmieding Concrete, Inc., 4101 N. 40th St., Lincoln, NE 68504-1205 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated February 23, 2021 executed under City Executive Order No. 95293, and County Contract C-21-0146, dated March 2, 2021, and executed by the City of Lincoln-Lancaster County Public Building Commission, on February 9, 2021, for Unit Price - Pavement/Concrete Services, Bid No. 21-003, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is March 1, 2021 through February 28, 2022, with the option to renew for one (1) additional one (1) year term upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning March 1, 2022 through February 28, 2023; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$250,000.00 for contracts without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$55,000.00 for contracts without approval by the Lancaster County Board of Commissioners; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$25,000.00 for contracts without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 95293 and County Contract C-21-0146, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning March 1, 2022 through February 28, 2023.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$250,000.00 for contracts without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$55,000.00 for contracts without approval by the Lancaster County Board of Commissioners.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$25,000.00 for contracts without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
