This Amendment is hereby entered into by and between Whitehead Oil Company, 2537 Randolph Street, Lincoln, NE 68510 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated June 19, 2020 executed under City Executive Order No. 94500, and County Contract C-20-0341, dated June 23, 2020, and executed by the City of Lincoln-Lancaster County Public Building Commission, on July 14, 2020, for Annual supply – Motor Fuel, Bid No. 20-137, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is June 21, 2020 through June 20, 2021, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 95406, executed by the City on March 31, 2021, and by County Contract C-21-0257, executed by the County Board on March 30, 2021, and executed by the City of Lincoln-Lancaster County Public Building Commission on April 20, 2021, to renew the contract for an additional one (1) year term from June 21, 2021 through June 20, 2022; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning June 21, 2022 through June 20, 2023; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$5,000,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$1,500,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$50,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order 94500 and County Contract C-20-0341, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning June 21, 2022 through June 20, 2023.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$5,000,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$1,500,000.00 without approval by the Lancaster County Board.

- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$50,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
