This Amendment is hereby entered into by and between Office Interiors & Design, Inc., 1401 Dahlberg Drive, Suite A, Lincoln, NE 68512 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated August 20, 2021 executed under City Directorial Order No. 26409, and County Contract C-21-0673, dated August 31, 2021, and executed by the City of Lincoln-Lancaster County Public Building Commission, on September 14, 2021, for Annual Service - Sit to Stand Workstation and Accessories, Quote No. 6404, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is September 12, 2021 through September 11, 2022, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning September 12, 2022 through September 11, 2023; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$30,000.00 for contracts without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$15,000.00 for contracts without approval by the Lancaster County Board of Commissioners; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$3,000.00 for contracts without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 26409 and County Contract C-21-0673, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning September 12, 2022 through September 11, 2023.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$30,000.00 for contracts without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$15,000.00 for contracts without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$3,000.00 for contracts without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
