This Amendment is hereby entered into by and between Midwest Alarm Services, 2900 South 70th Street, Suite 330, Lincoln, NE 68506 (hereinafter “Contractor”) and the City of Lincoln and City of Lincoln-Lancaster County Public Building Commission (hereinafter “Owners”), for the purpose of amending the Contract dated February 7, 2020 executed under City Directorial Order No. 23010 and executed by the City of Lincoln-Lancaster County Public Building Commission, on January 14, 2020, for Annual Service – Fire & Security Monitoring, Sole Source No. SS-102, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is February 7, 2020 through February 6, 2021, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Directorial Order No. 25065, executed by the City on January 25, 2021 and by the City of Lincoln-Lancaster County Public Building Commission on February 9, 2021, to renew the contract for an additional one (1) year term from February 7, 2021 through February 6, 2022; and

WHEREAS, the Contract was amended by City Directorial Order No. 27253, executed by the City on January 11, 2022 and by the City of Lincoln-Lancaster County Public Building Commission on February 15, 2022, to renew the contract for an additional one (1) year term from February 7, 2022 through February 6, 2023; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning February 7, 2023 through February 6, 2024; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$28,400.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$11,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 23010, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning February 7, 2023 through February 6, 2024.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$28,400.00 without approval by the City of Lincoln.

- 3) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$11,000.00 without approval by the Public Building Commission.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
