This Amendment is hereby entered into by and between Cornhusker State Industries, 800 Pioneers Blvd., Lincoln, NE 68502, (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated March 14, 2022 executed under City Directorial Order No. 27593, and County Contract C-22-0159, dated March 8, 2022, and executed by the City of Lincoln-Lancaster County Public Building Commission, on March 8, 2022, for Annual Supply – Envelope Supply and Printing, Bid No. 22-019, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is March 14, 2022 through March 13, 2023, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning March 14, 2023 through March 13, 2024; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$30,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$5,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$2,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 27593 and County Contract C-22-0159, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning March 14, 2023 through March 13, 2024.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$30,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$5,000.00 without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$2,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
