LANCASTER COUNTY BOARD OF COMMISSIONERS

The meeting was called to order at 9:00 a.m., the Pledge of Allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

1) MINUTES:

- A. Approval of the minutes of the Board of Commissioners meeting held on Tuesday, March 26, 2019.**

MOTION: Amundson moved and Schorr seconded approval of the minutes. Schorr, Flowerday, Amundson, Vest and Brinkman voted yes. Motion carried 5-0.

4) PUBLIC HEARING:

- A. Application for reconstruction of a licensed premise of a liquor license held by Numark Golf LLC, d/b/a Numark Golf Course located at 4944 South 89th Street, Lincoln, Lancaster County, Nebraska. (See correlating item 5A)**

The Chair opened the public hearing.

Kinsey Bauer, applicant, 8400 Augusta Drive, was administered the oath and said the old clubhouse was demolished at Numark Golf Course, previously located at 8901 Augusta Drive. The golf course will be moving 500 yards to the east, which will move the new clubhouse out of the City limits and into the County's jurisdiction.

No one appeared in opposition or in the neutral position.

The Chair closed the public hearing.

MOTION: Schorr moved and Amundson seconded approval of the resolution. Schorr, Flowerday, Amundson, Vest and Brinkman voted yes. Motion carried 5-0.

- B. Resolution in the matter of an application for deletion of a portion of licensed premise of a liquor license held by Numark Golf LLC, d/b/a Numark Golf Course located at 4944 South 89th Street, Lincoln, Lancaster County, Nebraska. (R-19-0025)**

MOTION: Amundson moved and Flowerday seconded approval of the resolution. Vest, Schorr, Flowerday, Amundson and Brinkman voted yes. Motion carried 5-0.

- C. Resolution in the matter of the emergency closure of Bridges S-179, Q-110, and Y-74 and Culvert M-38. (R-19-0026)**

Pam Dingman, County Engineer, said as the Engineering Department continues to inspect the County they have discovered several bridges that are a clear and present danger to the public. Dingman gave an overview of Bridges S-179, Q-110, Y-74 and Culvert M-38. (Exhibit A)

Schorr asked about the car count on bridge S-179. Dingman said the daily car count is 839 based on a 2012 traffic count. There was a newer count conducted over a mile away that indicated there has not been a significant increase from the 2012 study.

MOTION: Amundson moved and Flowerday seconded approval of the resolution. Amundson, Vest, Schorr, Flowerday and Brinkman voted yes. Motion carried 5-0.

- D. Special designated license application from Ken's Liquor, Inc., for an event on Friday, April 26, 2019 at Roca Ridge Event Center, 5265 Prairie Sage Drive, Roca, Nebraska.**

MOTION: Amundson moved and Vest seconded approval of the special designated license application. Flowerday, Amundson, Vest, Schorr and Brinkman voted yes. Motion carried 5-0.

- E. Contract with O'Reilly Auto Enterprises, LLC dba O'Reilly Auto Parts using the Sourcewell (Formerly NJPA) Contract No. 062916-ORA, State of Nebraska Participating Addendum No. 14690 OC, to provide Fleet Services Parts and Equipment. The term is upon execution through September 6, 2019. Upon conclusion of the initial term, the contract may be renewed for two additional one-year terms. The pricing will be pursuant to the lead contract. The cost to the County is not to exceed \$1,200. (C-19-0246)**

MOTION: Vest moved and Flowerday seconded approval of the contract. Schorr, Flowerday, Amundson, Vest and Brinkman voted yes. Motion carried 5-0.

- F. Acceptance of the Federal Grant Award 18-JJ-0001 from the Nebraska Commission on Law Enforcement and Criminal Justice in the amount of \$196,453 for FY 18 Addressing Training Needs for Juvenile Prosecutors for the period of October 1, 2018 through September 30, 2021. (C-19-0270)**

MOTION: Amundson moved and Vest seconded acceptance of the federal grant award. Vest, Schorr, Flowerday, Amundson and Brinkman voted yes. Motion carried 5-0.

G. Interlocal agreement with the City of Lincoln to define the roles and responsibilities with respect to certain pedestrian and bicycle trails that run under County Bridges O-175 and O-37 in Wilderness Park. (C-19-0271)

Dingman said there is currently pedestrian access that runs underneath both bridges. In 2015, the Federal Highway Administration advised the County and the City are required to have an interlocal agreement in place to allow a City trail under the bridge.

MOTION: Schorr moved and Amundson seconded approval of the interlocal agreement. Amundson, Vest, Schorr, Flowerday and Brinkman voted yes. Motion carried 5-0.

H. Recommendation from the Purchasing Agent and County Engineer to award a contract to Van Kirk Brothers Construction for South 82nd Street Grading (Bid 19-084). The total cost is \$1,204,820.57 (B-19-0084)

Dingman said completion of this project will provide an alternate route during the South Beltway project. The total cost came in higher than originally estimated, which will require some adjustments to the County Engineering budget.

MOTION: Amundson moved and Schorr seconded approval of the recommendation. Flowerday, Amundson, Vest, Schorr and Brinkman voted yes. Motion carried 5-0.

6) PUBLIC COMMENT: Those wishing to speak on items relating to County business not on the agenda may do so at this time.

Dingman explained there are a number of bridge closures that have occurred over the last several days. She discussed Bridges K-121, A-138 and A-151. (Exhibit B)


Vest ask how the Engineering Department intends to deal with Bridge K-121 as it has a higher daily car count. Dingman explained the goal is to figure out how to address the erosion around the bridge. The biggest issue is having no dry dirt due to the recent weather to stabilize the structures.



LANCASTER COUNTY SCOUR CRITICAL BRIDGES


