RESOLUTION NO. R-09-0007

WHEREAS, NEB.REV.STAT. §60-6,121 (Reissue 2004) provides that placement of traffic control devices is within the jurisdiction of the County; and

WHEREAS, the County Engineering Department has informed the County Board that with the conditional vacation of SW 86th Street between West Bennet Road and West Saltillo Road (Resolution R-08-0102), it is in the best interest of the traveling public to install the following signs at the following locations:

A. At the intersection of SW 86th Street and West Bennet Road:

1. Install a stop sign (R1-1) on SW 86th Street for northbound traffic at the West Bennet Road intersection. This will provide a 3-way stop at the intersection.
2. Install "3-way" signs (R1-3) below each Stop sign at the intersection.
3. Install a stop sign ahead sign (W3-1a) on SW 86th Street for northbound traffic approximately 500 feet south of the West Bennet Road intersection.
4. After two months from installation, make the following sign changes at the intersection of SW 86th Street and West Bennet Road:
 - a. Remove stop signs (R1-1) on West Bennet Road for eastbound and westbound traffic.
 - b. Remove "3-way" signs (R1-3) below each stop sign at the intersection.
 - c. Install "Cross Traffic Does Not Stop" signs (W40-2) below the stop sign on SW 86th Street for northbound traffic. Remove this warning sign after a six-month adjustment period.

B. On West Saltillo Road:

1. Install a Dead End sign (W14-1) on West Saltillo Road 50 feet west of SW 84th Street for westbound traffic.

C. At the intersection of SW 86th Street and West Saltillo Road:

1. Install five (5) end of road markers (W14-9) for westbound traffic.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to install the traffic signs at the locations designated herein.
