SUPPLEMENTING APPROPRIATIONS )  
FOR PREVIOUSLY ADOPTED BUDGET )  
FOR THE WEED CONTROL FUND AND )  
PROPERTY MANAGEMENT FUND )

RESOLUTION NO. R-09-0036

WHEREAS, Neb. Rev. Stat. §13-511 (2006 Cum. Supp.), provides that:

Unless otherwise provided by law, whenever during the current fiscal year or biennial period it becomes apparent to a governing body that (a) there are circumstances which could not reasonably have been anticipated at the time the budget for the current year or biennial period was adopted, (b) the budget adopted violated section 13-518 to 13-522, such that the revenue of the current fiscal year or biennial period for any fund thereof will be insufficient, additional expenses will be necessarily incurred, or there is a need to reduce the budget requirements to comply with sections 13-518 to 13-522, or (c) the governing body has been notified by the auditor of a mathematical or accounting error or noncompliance with the Nebraska Budget Act, such governing body may propose to revise the previously adopted budget statement and shall conduct a public hearing on such proposal.

WHEREAS, during the current fiscal year circumstances have arisen which could not reasonably have been anticipated at the time the budget was adopted;

WHEREAS, said circumstances include unanticipated salaries and operational costs; said circumstances are reflected in the record of the public hearing held on June 30, 2009;

WHEREAS, careful study has been made of appropriations needed for necessary expenditures for the remainder of the fiscal year; and

WHEREAS, notice of the place and time of a public hearing regarding increasing the appropriations to the Weed Control Fund in the amount of \$7,500 and the Property Management Fund in the amount of \$70,000 was published according to law; and

WHEREAS, a public hearing regarding the additional appropriations was held in conformance with said notice on June 30, 2009, at 9:30 a.m. in the Commissioners Hearing Room, First Floor, County-City Building.


NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, following public hearing, that additional appropriations of \$7,500 for the Weed Control Fund and \$70,000 for the Property Management Fund are hereby granted.
