WHEREAS, NEB. REV. STAT. § 23-1114 provides that the salaries of all elected officers of the County of Lancaster, Nebraska (“County”) shall be fixed by the County’s Board of County Commissioners (“County Board”) prior to January 15 of the year in which a general election will be held for the respective offices;

WHEREAS, 2022 is a year in which a general election will be held for the respective offices; and

WHEREAS, the County Board, with the assistance of a review committee comprised of citizens with expertise in governmental, business, legal, and personnel matters, has determined the appropriate salaries for the elected officers of Lancaster County for the 2023-2026 term;


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Lancaster, Nebraska, as follows:


1. That the annual salaries for the elected officers of the County for the 2023-2026 term of office are hereby fixed as stated in “Exhibit A”, attached hereto and made a part hereof by this reference.
2. That in no instance shall the salary of any elected officer be decreased from the previous year’s salary.


3. That it is the intent of the County Board that in the event any provision contained herein be found contrary to law, the remainder of this Resolution shall remain in full force and effect.

ELECTED OFFICER	2023	2024 - 2026
County Attorney	\$179,689.40	Annual increases effective January 1 st based on the following formula. If the U.S. Department of Labor Statistics Consumer Price Index (CPI) for all Urban Consumers Midwest Region, as published for the November immediately preceding each January for 2024 through 2026 is: <ul style="list-style-type: none"> <li data-bbox="873 877 1461 989">(a) Not less than 2.5% and not greater than 3.5% - then the salary increase for each elected official shall be 3%; <li data-bbox="873 1024 1495 1171">(b) Less than 2.5% - then the salary increase for each elected official shall be 3%, minus 50% of the amount by which the CPI is less than 2.5%; and <li data-bbox="873 1207 1484 1423">(c) Greater than 3.5% - then the salary increase for each elected official shall be 3%, plus 50% of the amount by which the CPI exceeds 3.5%, provided that the maximum salary increase shall not exceed 5%.
