AUTHORIZING THE INSTALLATION)
OF TRAFFIC SIGNS IN)
LANCASTER COUNTY)

RESOLUTION NO. R-10-0063

WHEREAS, NEB.REV.STAT. § 60-6,121 (Reissue 2004) provides that placement of traffic control devices is within the jurisdiction of the County; and

WHEREAS, NEB.REV.STAT. § 60-6,186(d) (Reissue 2004) provides that the maximum speed limit upon any highway that is not dustless surfaced and not part of the state highway system shall be 55 M.P.H.;

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to install the following signs at the following locations:

At the intersection of South 148th Street and Saltillo Road:

1. Install stop signs (R1-1) on South 148th Street for northbound and southbound traffic at the Saltillo Road intersection. This will provide a 4-way stop at the intersection.
2. Install "all way" signs (R1-4) below each Stop sign at the intersection.
3. Install stop ahead signs (W3-1a), one for northbound traffic on South 148th Street approximately 500 feet south of the Saltillo Road intersection, and one for southbound traffic on South 148th Street approximately 500 feet north of the Saltillo Road intersection.
4. After two months from installation, make the following sign changes at the intersection of South 148th Street and Saltillo Road:
 - A. Remove stop signs (R1-1) on Saltillo Road for eastbound and westbound traffic.
 - B. Remove "all way" signs (R1-4) below each stop sign at the intersection.
 - C. Install "Cross Traffic Does Not Stop" signs (W40-2) below the stop signs

on South 148th Street for northbound and southbound traffic. Remove these warning signs after a six-month adjustment period.

Install 55 M.P.H. signs (R2-1) at the following locations:


1. South 82nd Street just south of Roca Road for southbound traffic.
2. South 82nd Street just north of Hickman Road for northbound traffic.
3. South 82nd Street just south of Hickman Road for southbound traffic.
4. South 82nd Street just north of Panama Road for northbound traffic.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to install and remove such traffic signs at the locations designated herein.


