WHEREAS, the Board of County Commissioners of Lancaster County, Nebraska, ("the Board"), pursuant to Neb. Rev. Stat. § 39-1722 (Reissue 2008), received a report from the Lancaster County Engineer and the Lincoln-Lancaster County Planning Department regarding the vacation of North Street abutting Lot 1, Block 1, as platted in the unincorporated village of Agnew, more particularly described as North Street between the northerly extension of the west line of said Block 1, and the northwesterly extension of the easterly line of said Block 1, Agnew, all located in the SW 1/4 of Section 12, Township 12 North, Range 5 East, of the 6th Principal Meridian, Lancaster County, Nebraska, as provided in Attachment "A", which is attached hereto and incorporated by this reference.

NOW, THEREFORE, BE IT RESOLVED, by the Board as follows:

1) That a public hearing on the vacation for the aforesaid described road is hereby set for the 18th day of January, 2011, at 9:30 a.m., or as soon thereafter as is practicable, in the County Commissioners Hearing Room, Room 112, on the first floor of the County-City Building, 555 South 10th Street, Lincoln, Lancaster County, Nebraska.


2) That the Lancaster County Clerk should be and hereby is directed to publish this resolution once a week for three consecutive weeks in a legal newspaper of the County and is




