

Special Election Early Vote Ballot Request

This early voting ballot application is for the June 28, 2022 Special Congressional Election. To request an early voting ballot for this election, *complete the form, sign and return it to the Election Commission* by either mail, email, fax or hand delivery.

If you have an address change within Lancaster County, you may use this form to update your address and also request an early voting ballot.

In accordance with State Law, early voting ballots will be mailed starting June 10. If your ballot application is received by my office after June 10, please allow 3 to 5 working days for us to process and mail your ballot.

A person may assist up to two voters by acting as their agent. The agent can complete and submit the early voting ballot application of behalf of the voter. A candidate or a member of a candidate campaign committee can only be an agent for his/her own family.

The deadlines for requesting an early voting ballot:

Request by mail, fax or email: 6:00 p.m., Friday, June 17, 2022
 Request in person: 5:00 p.m., Monday, June 27, 2022
 Request by agent: 7:00 p.m., Election Day, June 28, 2022
