WHEREAS, the Lincoln-Lancaster County Health Department has recommended an amendment to increase the fees for on-site wastewater treatment permits, as provided in Attachment "A," attached hereto and incorporated by this reference; and

WHEREAS, on October 2, 2012, the Board of Commissioners of Lancaster County, Nebraska, conducted a public hearing regarding the adoption of the amendments to Resolution No. 02-30, Regulation of On-Site Wastewater Treatment Systems, as provided in Attachment "A"; and








BE, IT FURTHER RESOLVED, that a copy of this resolution and said amendments be placed on file in the office of the County Clerk.

**CR 02-30 On-site Wastewater Treatment Systems**

Section XIII. FEES

The following fees for permits are required:

- (a) On-site wastewater treatment system construction permit fee:
  - Standard System . . . . . ~~\$345.00~~ \$355.00
  - Non-standard System . . . . . ~~\$495.00~~ \$510.00
  
- (b) On-site wastewater treatment system repair permit fee . . . . . ~~\$190.00~~ \$195.00
  
- ~~(c) Non-standard on-site wastewater treatment system annual operating permit fee . . . . . \$70.00~~
  
- ~~(d)~~(c) Cleaner's permit fee (annual) . . . . . ~~\$390.00~~ \$400.00  
This permit is issued on an annual basis, expires on May 31 of each year, and is renewable on payment of the annual fee and demonstrated compliance with the requirements of this chapter.
  
- ~~(e)~~(d) Any person who secures a master installer or journeyman installer registration certificate pursuant to this chapter shall pay the following respective fee:
  - (1) Master Installer . . . . . \$30.00
  - (2) Journeyman Installer . . . . . \$30.00
  - (3) Inspector . . . . . \$30.00
  - (4) Soil Evaluator . . . . . \$30.00
  - (5) Multiple category . . . . . \$30.00
  
- ~~(f)~~(e) Permit Extension Fee . . . . . ~~\$100.00~~ \$105.00
  
- ~~(g)~~(f) Variance Fee . . . . . ~~\$190.00~~ \$195.00
  
- ~~(h)~~(g) Reinstatement Fee . . . . . ~~\$190.00~~ \$195.00
  
- ~~(i)~~(h) Development area review fees  
A base fee and a per lot fee shall be paid for Health Director review of any development area as follows:
  - Base fee . . . . . ~~\$345.00~~ \$355.00
  - Per lot fee . . . . . \$30.00
  - Maximum combined base fee and per lot fee . . . . . \$1,200.00
  
- ~~(j)~~(i) All fees are payable to the Lincoln-Lancaster County Health Department and shall be credited to the Health Fund. No fees will be refunded.
