WHEREAS, Fox Run and Fox Run 1st through 4th additions are validly platted subdivisions located in Lancaster County and;

WHEREAS, representatives of said Fox Run and Fox Run 1st through 4th additions have requested that the County provide maintenance for roads located therein.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that Lancaster County hereby accepts for County maintenance for certain roads and streets located within Fox Run and Fox Run 1st through 4th additions to wit:

Roadways of approximately 4,374 linear feet in length and to include the following:

- 1) Approximately 2630 feet of Fox Run Road
- 2) Approximately 520 feet of S. 156th Street
- 3) Approximately 437 feet of S. 158th Street
- 4) Approximately 787 feet of S. 160th Street

All located in the NE 1/4 of Section 27, Township 9 North, Range 8 East of the 6th Principal Meridian, Lancaster County, Nebraska, as shown on Exhibit "A" attached hereto and incorporated herein by this reference.

BE IT FURTHER RESOLVED that County Maintenance for the roads and streets listed above shall be exclusively limited to the following maintenance items:

1. Maintaining surfacing and subgrade of public roadways as per County requirements;
2. Maintaining roadway drainage ditches and drainage culverts as per County requirements;
3. Maintaining development signing as per County requirements; and
4. Snow plowing of public roadways in accordance with County standard practice.

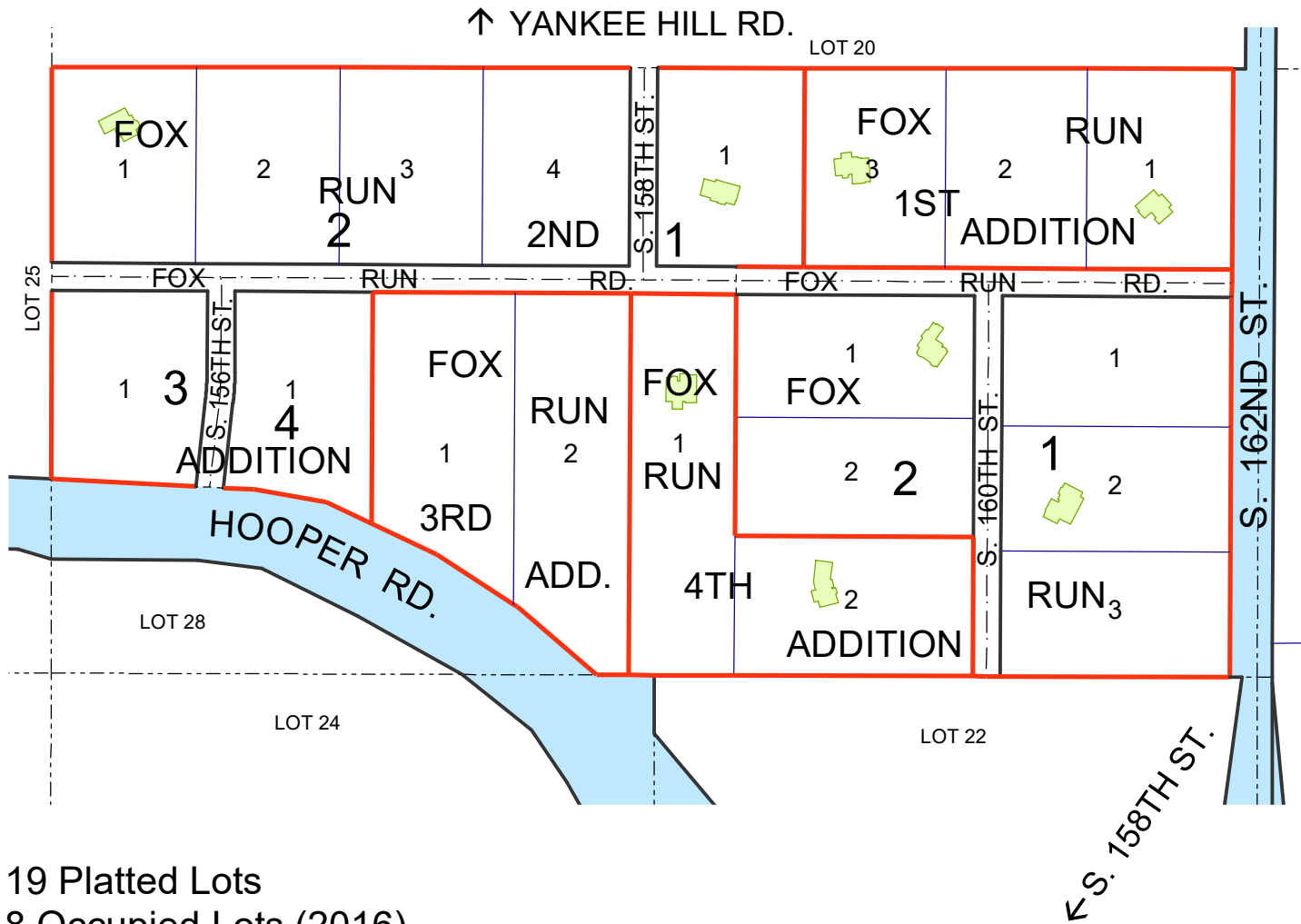

Direct vehicular access to Hooper Road is hereby relinquished except for South 156th Street.

FOX RUN & 1ST ADD.

NOTE: Each lot shall only have one residential access.
Direct vehicular access to S. 162nd St is hereby relinquished except at Fox Run Rd.

FOX RUN 2ND, 3RD & 4TH ADD.

NOTE: Each lot shall have no more than two accesses to the public
