INSTRUCTIONS TO VOTER

You are a voter residing in Palmyra School District OR-1. This is your ballot for the Palmyra School District Bond Election. The date of the Election is August 9, 2022. Per Nebraska State Law this election is being conducted through the mail and no polling locations will be used. Below you will find the instructions on how to cast your ballot and return it.

Nebraska Law requires that the signature of an election official must appear at the bottom of your ballot. If there is not a signature on your ballot, please contact the Lancaster County Election Commissioner's Office immediately at (402) 441-7311

How to Vote the Ballot

- Use a black ink pen to mark your ballot. Do not use a marker.
• To vote you must blacken the oval completely, (●)
• If you make a mistake in marking your ballot, do not cross out or erase the error. Write "VOID" across the face of the ballot and call the Lancaster County Election Commission at (402) 441-7311 for instructions.

How to Return the Voted Ballot

- 1) Place the voted ballot in the Identification Envelope and seal. Do Not Place more than one ballot in the envelope.
2) Sign the Identification Envelope & Voter's Oath where indicated and provide your street address on the 'Residence Address' line.
3) If you are returning your ballot by mail, place one (1) first class postage stamp on the envelope.
4) Mail or hand-deliver your ballot to the Lancaster County Election Office, 601 N 46th St., Lincoln, NE 68503
• For your convenience, a Drop Box is located outside the main entrance of the Election Office.
5) All ballots must be in the possession of the Lancaster County Election Commissioner no later than 5:00 p.m., August 9, 2022.

Failure to complete and sign the Identification Envelope/Voter's Oath may result in your ballot NOT being counted.

"Shall Otoe County School District 0501 (Palmyra District OR-1) in the State of Nebraska issue its bonds in a total principal amount not to exceed Twenty-Two Million Dollars (\$22,000,000) to provide funds to (i) construct additions to and renovations of the Bennet Elementary School building to include new classrooms, an expanded kitchen and commons area and a new school entry, and (ii) construct additions to and renovations of the Palmyra Jr./Sr. High School building to include new classrooms, career and technical education space, administrative offices and a commons area, and (iii) acquire, install and/or construct the necessary furniture, equipment, apparatus and site improvements for such additions and buildings; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"

- FOR said bonds and tax

Qualified electors voting in favor of said proposition shall blacken the oval opposite the words "FOR said bonds and tax" following said proposition, and qualified electors voting against said proposition shall blacken the oval opposite the words "AGAINST said bonds and tax" following said proposition.
