WHEREAS, the Board of County Commissioners of Lancaster County, Nebraska, desires to adopt the 2022-2023 annual cost of living wage adjustment for certain unrepresented employees in the classified service, employees in the job titles Attorney I, Attorney II, District Court Staff Attorney, Law Clerk, Emergency Management Specialist, and Deputy Sheriff Captains.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County as follows:

- 1) That for the 2022-2023 year, Classified, unrepresented employees in the "C" Classification shall receive a cost of living increase in the amount of 3.25%.
- 2) That for the 2022-2023 year, Classified, unrepresented employees in the "E" Classification shall receive a cost of living increase in the amount of 3.25%.
- 3) That for the 2022-2023 year, pursuant to Lancaster County Board of Commissioners Resolutions R-12-099 and R-13-001, Attorney I's and II's shall receive a cost of living increase in the amount of 3.25%.
- 4) That for the 2022-2023 year, pursuant to Lancaster County Board of Commissioners Resolution R-17-0054, District Court Staff Attorneys shall receive a cost of living increase in the amount of 3.25%.
- 5) That for the 2022-2023 year, Law Clerks shall receive a cost of living increase in the amount of 3.25%.
- 6) That for the 2022-2023 year, pursuant to Lancaster County Board of Commissioners Resolution R-21-0010, Emergency Management Specialists shall receive a cost of living increase in the amount of 3.25%.

- 7) That for the 2022-2023 year, pursuant to Lancaster County Board of Commissioners Resolution R-22-0020, Deputy Sheriff Captains shall receive a cost of living increase in the amount of 3.25%.
- 8) That the foregoing wage adjustment shall take effect for the pay period beginning August 11, 2022.
