RESOLUTION NO. R-22-0109

WHEREAS, West Van Dorn Estates and West Van Dorn Estates 1<sup>st</sup> and 2nd Additions are validly platted subdivisions located in Lancaster County and;

WHEREAS, representatives of said West Van Dorn Estates and West Van Dorn Estates 1<sup>st</sup> and 2nd Additions have requested that the County provide maintenance for roads located therein.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that Lancaster County hereby accepts for County maintenance for certain roads and streets located within West Van Dorn Estates and West Van Dorn Estates 1<sup>st</sup> and 2nd Additions to wit:

Roadways of approximately 5,587 linear feet in length and to include the following:

- 1) Approximately 409 feet of Paris Court
- 2) Approximately 465 feet of Roman Drive
- 3) Approximately 418 feet of W. Athens Court
- 4) Approximately 1688 feet of Apollo Drive
- 5) Approximately 438 feet of SW. 102<sup>nd</sup> Street
- 6) Approximately 2169 feet of SW. 100<sup>th</sup> Street

All located in the NE 1/4 of Section 4, Township 9 North, Range 5 East of the 6th Principal Meridian, Lancaster County, Nebraska, as shown on Exhibit "A" attached hereto and incorporated herein by this reference.

BE IT FURTHER RESOLVED that County Maintenance for the roads and streets listed above shall be exclusively limited to the following maintenance items:

1. Maintaining surfacing and subgrade of public roadways as per County requirements;
2. Maintaining roadway drainage ditches and drainage culverts as per County requirements;
3. Maintaining development signing as per County requirements; and
4. Snow plowing of public roadways in accordance with County standard practice.

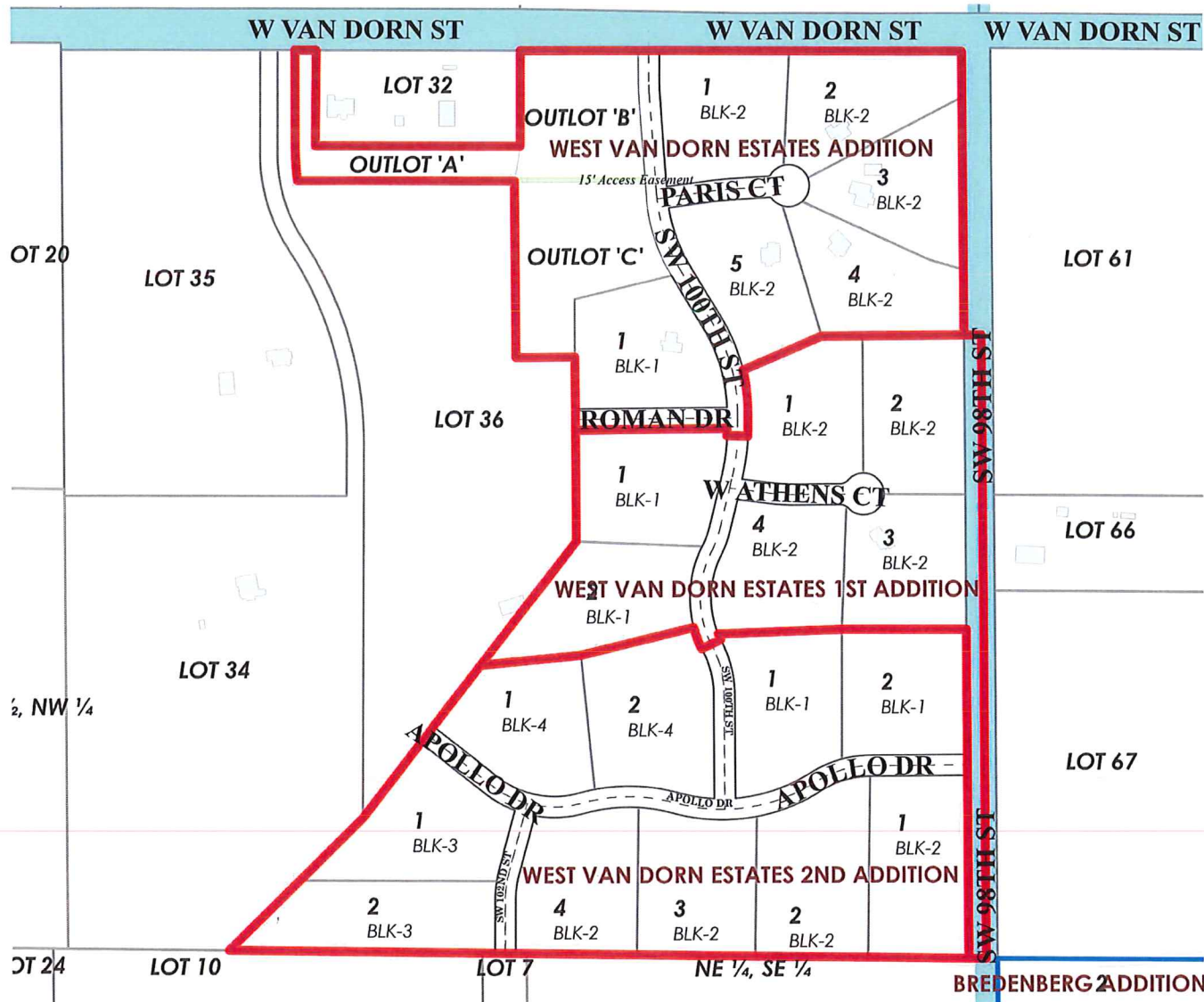
