AUTHORIZING THE TEMPORARY INSTALLATION OF TRAFFIC SIGNS IN LANCASTER COUNTY)) RESOLUTION NO. R - 1 4 - 0 0 3 0)

WHEREAS, NEB. REV. STAT. § 60-6,121 (Reissue 2004) provides that placement of traffic control devices is within the jurisdiction of the County; and

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to temporarily install the following signs at the listed locations due to an anticipated increase traffic on A Street due to a construction project on US Highway 34 east of Lincoln, Lancaster County, Nebraska:

- 1. On A Street just east of South 120th Street replace the existing 50 M.P.H. speed limit sign (R2-1) with a 40 M.P.H. sign (R2-1) for eastbound traffic;
2. On A Street just west of South 134th Street install a 40 M.P.H. sign (R2-1) for westbound traffic;
3. On A street just east of South 134th Street install a 40 M.P.H. sign (R2-1) for eastbound traffic;
4. On A street just west of South 148th Street install a 40 M.P.H. sign (R2-1) for westbound traffic.

Upon the completion of the construction project on US Highway 34 east of Lincoln, Lancaster County, Nebraska, the following action will be taken:

- 1. On A Street just east of South 120th Street replaced the existing 40 M.P.H. sign (R2-1) with a 50 M.P.H. sign (R2-1) for eastbound traffic;
2. On A Street just west of South 134th Street remove the 40 M.P.H. sign (R2-1) for westbound traffic;
3. On A Street just east of South 134th Street remove the 40 M.P.H. sign (R2-1) for eastbound traffic;
4. On A Street just west of South 148th Street remove the 40 M.P.H. sign (R2-1) for westbound traffic.


NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to temporary install such traffic

signs at the locations designated herein and remove those signs upon completion of the construction project on US Highway 34 east of Lincoln, Lancaster County, Nebraska.


