

2023 Lincoln City Elections Early Vote Ballot Application

This is your early vote ballot application for the April 4, 2023 Primary Election and May 2, 2023 General Election. To request an early vote ballot for one or both elections, complete the form, sign and return it to the Election Commission by mail, email, fax or hand deliver. The application may also be deposited in the Election Commissioner's Drop Box located at 601 N 46th St, Lincoln.

If you have an address change within Lancaster County, you may use this form to update your address and request an early vote ballot.

An agent may assist up to 2 voters by completing and submitting the early vote applications on their behalf. A candidate or a member of a candidate campaign committee can only assist their own family.
