AUTHORIZING INSTALLATION)
OF A TRAFFIC SIGNS IN) RESOLUTION NO. R-116-0025
LANCASTER COUNTY)

WHEREAS, NEB. REV. STAT. § 60-6,121 (Reissue 2010) provides that placement of traffic control devices is within the jurisdiction of the County;

WHEREAS, the intersection of S. 155th St. and Stagecoach Rd. Is a T-intersection that has a Stop sign for eastbound traffic, a Yield sign for northbound traffic, and no traffic control for westbound traffic;

WHEREAS, District 4 requested that the Lancaster County Engineer consider changing traffic control at the intersection of S. 155th St. and Stagecoach Rd.;

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to make the following initial miscellaneous sign changes in Lancaster County, at the intersection of S. 155th St. and Stagecoach Rd.:

1. Install a "Stop" sign (R1-1) on Stagecoach Rd for westbound traffic;
2. Replace the northbound "Yield" Sign (R1-2) with a "Stop" Sign (R1-1);
3. Install "All Way" signs "R1-3" below each Stop sign at the intersection; and
4. Install a "Stop Ahead" sign (W3-1) on Stagecoach Rd for westbound traffic; and

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to make the following miscellaneous sign changes two months after the initial changes described above in Lancaster County, at the intersection of S. 155th St. and Stagecoach Rd.:

1. Remove "Stop" Signs (R1-1) on Stagecoach Rd for eastbound and westbound traffic;
2. Remove "All Way" signs (R1-3) below each stop sign at the intersection;
3. Remove the "Stop Ahead" Sign on (W3-1) Stagecoach Rd for westbound traffic;
4. Install a "Cross Traffic Does Not Stop" sign (W40-2) below the northbound stop sign on S 155th St; and

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to make the following miscellaneous sign change six months after the initial changes described above in Lancaster County, at the intersection of S. 155th St. and Stagecoach Rd.

1. Remove the "Cross Traffic Does Not Stop" sign (W40-2) below the northbound stop sign on S 155th St.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to make the traffic sign changes at the location designated herein.
