RESOLUTION NO. R-16-0051

WHEREAS, the County Engineer on August 15, 2016, discovered that Bridge H-66, located 250' South of the Northwest Corner of Section 31, Township 11, Range 8, more commonly known as North 112th Street, approximately 250' South of the intersection of Alvo Road and North 112th, presents a clear and present danger to the public; and

WHEREAS, the County Engineer on August 15, 2016, discovered that Bridge H-120, located 0.35 miles South of the Northwest corner of Section 13, Township 11, Range 8, more commonly known as North 176th Street, approximately 0.35 miles South of the intersection of Waverly Road and South 176th Street, presents a clear and present danger to the public; and

WHEREAS, the County Engineer on August 15, 2016, discovered that Bridge X-9, located 0.1 miles South of the West ¼ corner of Section 19, Township 7, Range 7, more commonly known as South 25th Street, approximately 0.4 miles North of the intersection of Pella Road and South 25th Street, presents a clear and present danger to the public; and

WHEREAS, the County Engineer recommended the closure of Bridge H-66, Bridge H-120, and Bridge X-9; and

WHEREAS, general supervision and control of the public roads of Lancaster County ("County") is vested in the Board of County Commissioners of Lancaster County, Nebraska, (the "Board") pursuant to Neb. Rev. Stat. § 39-1402; and

WHEREAS, the timing of the discovery of the clear and present danger prevented the Board from amending the agenda within 24 hours of the August 16, 2016, meeting of the Board as

otherwise required by Neb. Rev. Stat. § 84-1411(1); and

WHEREAS, the Board found that discussion of the closure of Bridge H-66, Bridge H-120, and Bridge X-9 constituted an item of an emergency nature; and


WHEREAS, the Board modified the agenda of its August 16, 2016, public meeting to include this item of an emergency nature at the public meeting held on August 16, 2016, pursuant to Neb. Rev. Stat. § 84-1411(1) in compliance with the Nebraska Open Meetings Act;





