AUTHORIZING INSTALLATION)
AND REMOVAL OF TRAFFIC SIGNS) RESOLUTION NO. R-16-0081
IN LANCASTER COUNTY)

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that placement of traffic control devices is within the jurisdiction of the County;

WHEREAS, a citizen requested a 55 M.P.H. sign on S. 56th St. in Lancaster County as described herein;

WHEREAS, the additional sign installations and removals are required upon the completion of construction projects on various county roads as described herein; and

WHEREAS, the County Engineering Department has informed the County Board that it is in the best interest of the traveling public to install or remove these signs in Lancaster County, at the following more particularly described locations:

1. Install a Speed Limit 55 M.P.H. sign (R2-1) on S. 56th St. 100' north of Saltillo Rd. for northbound traffic;
2. Install a Speed Limit 55 M.P.H. sign (R2-1) on Bluff Rd. just east of the Waverly City limit for eastbound traffic;
3. Install a Speed Zone Ahead 40 M.P.H. sign (W3-5) on Bluff Rd. 250' east of the Waverly City limit for westbound traffic;
4. Install a "Pavement Ends" sign (W8-3) on Bluff Rd. approximately 300' east of N. 176th St. for eastbound traffic;
5. Install a Speed Limit 50 M.P.H. (R2-1) on Bluff Rd. approximately 900' east of N. 176th St. for eastbound traffic;
6. Install a Speed Limit 55 M.P.H. sign (R2-1) on Old Cheney Rd. just west of S. 190th St. for westbound traffic;


7. Remove a "Pavement Ends" sign (W8-3) on W. Denton Rd. approximately 500' east of SW. 112th St. for westbound traffic;
8. Remove a Speed Limit 50 M.P.H. (R2-1) on W. Denton Rd. just west of SW. 112th St. for westbound traffic; and
9. Install a Speed Limit 55 M.P.H. sign (R2-1) on W. Denton Rd. just east of SW. 142nd St. for eastbound traffic.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to the Lancaster County Engineer to install or remove the traffic signs at the locations designated herein.
