

Statewide Primary Election Early Voting Ballot Application

This early voting ballot application is for the May 14, 2024 Statewide Primary Election. To request an early voting ballot for this election, *complete this form, sign, and return it to the Election Commission* by mail, email, fax, drop box, or hand delivery.

If you have an address change within Lancaster County, you may use this form to update your address and also request an early voting ballot.

In accordance with State Law, early voting ballots will be mailed starting April 8. If your ballot application is received by my office after April 8, please allow 3 to 5 working days for us to process and mail your ballot.

A person may assist up to two voters by acting as their agent. The agent can complete and submit the early voting ballot application on behalf of the voter. A candidate or a member of the candidate campaign committee can only be an agent for their own family.

The penalty for election falsification is imprisonment for up to two years and twelve months post-release supervision, a fine not to exceed \$10,000, or both.

An Agent is a person who requests a ballot for another voter. An Agent may request ballots for up to two (2) voters per election.
