AUTHORIZING TEMPORARY )  
INSTALLATION OF TRAFFIC CONTROL) RESOLUTION NO. R-17-0076  
DEVICES IN LANCASTER COUNTY )

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that Lancaster County (“County”) shall place and maintain such traffic control devices upon highways within its jurisdiction to carry out the provisions of the Nebraska Rules of the Road or to regulate, warn, or guide traffic;

WHEREAS, NEB. REV. STAT. § 60-670 provides that traffic control devices include any sign, signal, marking, or other device not inconsistent with the Nebraska Rules of the Road placed or erected by authority of the County for the purpose of regulating, warning, or guiding traffic;

WHEREAS, the Lancaster County Engineer (“Engineer”) in the Engineer’s capacity as County Highway Superintendent, has control, government, and supervision of all the public roads and bridges in the County under the general supervision and control of the County Board of County Commissioners (“Board”) pursuant to Neb. Rev. Stat. § 39-1507; and

WHEREAS, due to the commencement of construction on County Structures H-128, H-130 & J-143, all of which are located on N 148<sup>th</sup> St. between “O” St. and McKelvie Rd. and all of which will require road closures with detour routes, the Engineer has informed the Board that it is in the best interest of the traveling public to take the following actions with respect to traffic control devices in the County, at the following more particularly described locations:

1. Install the following traffic control devices during the closure of each Structure and its associated road(s) as follows:
  - a. For Structure J-143’s closure:

- i. A 40 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just north of O St. for northbound traffic; and
  - ii. A 40 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just south of Holdrege St. for southbound traffic.
- b. For Structure H-130's closure:
- i. A 40 M.P.H. (R2-1) speed limit sign On Fletcher Ave just west of N 148<sup>th</sup> St. for westbound traffic;
  - ii. A 40 M.P.H. (R2-1) speed limit sign On Fletcher Ave just east of N 134<sup>th</sup> St. for eastbound traffic;
  - iii. A 50 M.P.H. (R2-1) speed limit sign On Fletcher Ave just west of N 134<sup>th</sup> St. for westbound traffic;
  - iv. A 40 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just north of Fletcher Ave for northbound traffic;
  - v. A 40 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just south of Alvo Rd. for southbound traffic;
  - vi. A 50 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just south of Fletcher Ave for southbound traffic;
  - vii. A 50 M.P.H. (R2-1) speed limit sign on N 134<sup>th</sup> St. just north of Alvo Rd. for northbound traffic;
  - viii. A 40 M.P.H. (R2-1) speed limit sign On Alvo Rd. just west of N 148<sup>th</sup> St. for westbound traffic;
  - ix. A 40 M.P.H. (R2-1) speed limit sign On Alvo Rd. just east of N 134<sup>th</sup> St. for eastbound traffic; and
  - x. A 50 M.P.H. (R2-1) speed limit sign On Alvo Rd. just west of N 134<sup>th</sup> St. for westbound traffic;
- c. For Structure H-128's closure:
- i. A 40 M.P.H. (R2-1) speed limit sign On Alvo Rd. just east of N 148<sup>th</sup> St. for eastbound traffic;
  - ii. A 40 M.P.H. (R2-1) speed limit sign On Alvo Rd. just west of N 162<sup>nd</sup> St. for westbound traffic;

- iii. A 50 M.P.H. (R2-1) speed limit sign On Alvo Rd. just east of N 162<sup>nd</sup> St. for eastbound traffic;
- iv. A 40 M.P.H. (R2-1) speed limit sign on N 162<sup>nd</sup> St. just north of Alvo Rd. for northbound traffic;
- v. A 40 M.P.H. (R2-1) speed limit sign on N 162<sup>nd</sup> St. just south of McKelvie Rd. for southbound traffic;
- vi. A 50 M.P.H. (R2-1) speed limit sign on N 162<sup>nd</sup> St. just south of Alvo Rd. for southbound traffic;
- vii. A 50 M.P.H. (R2-1) speed limit sign on N 162<sup>nd</sup> St. just north of McKelvie Rd. for northbound traffic;
- viii. A 40 M.P.H. (R2-1) speed limit sign McKelvie Rd. just west of N 162<sup>nd</sup> St. for westbound traffic;
- ix. A 40 M.P.H. (R2-1) speed limit sign McKelvie Rd. just east of N 148<sup>th</sup> St. for eastbound traffic; and
- x. A 50 M.P.H. (R2-1) speed limit sign McKelvie Rd. just east of N 162<sup>nd</sup> St. for eastbound traffic.


- 2. Upon completion of bridge repair to each Structure and the reopening of the Structure and its associated road(s), remove the traffic control devices that had been installed for each Structure's closure pursuant to Paragraph 1 above;




