WHEREAS, on October 9, 2018, pursuant to Neb. Rev. Stat. §§ 39-1722, the Lancaster County Board of Commissioners (“County Board”), passed County Resolution No. R-18-0072, directing the Lancaster County Engineer to conduct a study and the Lincoln/Lancaster County Planning Department to write a report and get the City of Lincoln’s approval regarding a request to vacate the twenty five foot right-of-way adjacent to the east line of Lot 6 IT and the west line of Lots 7, 8, and 9, Block 3 of Gieren’s First Addition, Walton, Nebraska, located in Lancaster County, Nebraska;

WHEREAS, on October 12, 2018, the petitioners requesting the vacation officially withdrew their petition (Exhibit “A”); and

WHEREAS, the County Board desires to rescind its directive to the Lancaster County Engineer and Lincoln/Lancaster County Planning Department.

NOW, THEREFORE, BE IT RESOLVED, by the Lancaster County Board of Commissioners that Lancaster County Resolution No. R-18-0072, directing the Lancaster County Engineer to conduct a study and the Lincoln/Lancaster County Planning Department to write a report and get the City of Lincoln’s approval regarding a request to vacate, is hereby rescinded.
