IN LANCASTER COUNTY                 )

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that Lancaster County (“County”) shall place and maintain such traffic control devices upon highways within its jurisdiction to carry out the provisions of the Nebraska Rules of the Road or to regulate, warn, or guide traffic;

WHEREAS, NEB. REV. STAT. § 60-670 provides that traffic control devices include any sign, signal, marking, or other device not inconsistent with the Nebraska Rules of the Road placed or erected by authority of the County for the purpose of regulating, warning, or guiding traffic;

WHEREAS, the Lancaster County Engineer (“Engineer”) in the Engineer’s capacity as County Highway Superintendent, has control, government, and supervision of all the public roads and bridges in the County under the general supervision and control of the County Board of County Commissioners (“Board”) pursuant to Neb. Rev. Stat. § 39-1507; and

WHEREAS, the Engineer has informed the Board that it is in the best interest of the traveling public to create an all-way stop by installing the following traffic control devices in the County, at the following more particularly described location:

1. At the intersection of N 1st St & Branched Oak Rd:
  - a. Install a Stop Sign (R1-1) for eastbound traffic.
  - b. Install a Stop Sign (R1-1) for westbound traffic.
  - c. Install a Stop Ahead Sign (W3-1) 500’ east of the intersection for westbound traffic.

d. Install all-way signs (R1-3) below each stop sign.




