OF S.W. 91<sup>ST</sup> STREET, MORE PARTICULARLY )  
DESCRIBED IN RESOLUTION R-19-0036, )  
LOCATED IN LANCASTER COUNTY, )  
NEBRASKA )

WHEREAS, pursuant to Neb. Rev. Stat. §§ 39-1722 et seq., the Lancaster County Board of County Commissioners (“Board”) resolved under Resolution R-19-0036 that:

1. The Lancaster County Engineer (“Engineer”), or such person designated by the Engineer, shall conduct a study of the use being made of portions of S.W. 91<sup>st</sup> Street, more particularly described in Resolution R-19-0036, and shall submit in writing to the Board within thirty days a report upon the study made of, and a recommendation regarding, the proposed vacation of portions of S.W. 91<sup>st</sup> Street; and that the study shall include procuring a title search of the above-described portion of public road; and
2. The Lincoln-Lancaster Planning Department (“Planning”) shall write a report as to the character and degree of conformity or nonconformity of the proposed vacation of portions of S.W. 91<sup>st</sup> Street to the Comprehensive Plan and shall submit in writing to the Board within thirty days a report and its recommendation regarding the proposed vacation of portions of S.W. 91<sup>st</sup> Street. Planning shall also determine whether the public road to be vacated is within three miles of a city of the metropolitan, primary, or first class. If the


public road to be vacated is within three miles of the City of Lincoln, Planning will initiate this process to get the City Council's approval; and


WHEREAS, the Board wishes to rescind Resolution R-19-0036 directing the Engineer and Planning to conduct such reports as described above;

NOW, THEREFORE, BE IT RESOLVED by the Board that Resolution R-19-0036 is hereby rescinded.


