WHEREAS, pursuant to NEB. REV. STAT. § 33-140, the Lancaster County Board of County Commissioners ("the Board"), has been informed that there are remaining with Lancaster County certain unclaimed witness fees and refunds that have remained unclaimed for a period of more than six months since the respective amounts were paid into the County Clerk's Office. An affidavit signed by the Lancaster County Clerk ("Clerk") is attached hereto as Attachment "A" that refers to and incorporates the list of such fees as Exhibit "A", both of which are incorporated herein by this reference; and

WHEREAS, pursuant to NEB. REV. STAT. § 33-140.01, the Board shall, within twenty days after the filing of the list provided by § 33-140, cause to be published, for at least two consecutive issues of the paper, a notice generally indicating that certain witness fees and unclaimed funds remain;

NOW, THEREFORE, BE IT RESOLVED by the Board that the Clerk is hereby directed to cause to be published in a weekly newspaper of general circulation, published in the County, for at least two consecutive issues of the paper, a notice in a form substantially as follows:


To whom it may concern: Report has been made to the County Board of Lancaster County, Nebraska, by the clerk of the district or county court of the county, which report shows that there is now and has been for the last six months remaining in the hands of the clerk certain witness fees which have been uncalled for. If the fees are not called for within six months from

July 9, 2019, they will be considered as  
forfeited and will be paid into the common school  
fund of Lancaster County.


The list, marked Exhibit "A", attached hereto and made a part hereof, shows the cases in which such fees have been paid and remain unclaimed with the amounts in each case.
