

Statewide Primary Election Early Voting Ballot Application

This early vote/absentee ballot application is for the May 12, 2020 Primary Election. To request an early voting ballot for this election, *complete the form, sign and return it to the Election Commission* by either mail, email, fax or hand deliver.

If you have an address change within Lancaster County, you may use this form to update your address and request an early voting ballot.

In accordance with State Law, early voting ballots will be mailed starting April 6. If your ballot request is received by my office after April 6, please allow 3 to 5 working days for us to process and mail your ballot.

A person may assist up to two voters by acting as their agent. An agent can complete and submit the early voting ballot application on behalf of the voter. A candidate or a member of a candidate campaign committee can only be an agent for his/her own family.

The deadlines for requesting an early vote/absentee ballot are as follows:

Request by mail, fax or email: 6:00 p.m., Fri., May 1, 2020
 Request in person: 5:00 p.m., Mon., May 11, 2020
 Request by agent: 7:00 p.m., Election Day, May 12, 2020
