WHEREAS, pursuant to Neb. Rev. Stat. § 39-1402, the Lancaster County Board of County Commissioners (“Board”) has general supervision and control of the public roads in Lancaster County (“County”), including the power and authority to establish, improve, maintain and abandon public roads in the County, and to enforce the laws in relation thereto;

WHEREAS, the Nebraska Department of Transportation is constructing a new 11.5-mile-long four-lane divided freeway along the southern perimeter of the City of Lincoln. The project begins on U.S. Highway 77 between Saltillo Road and Bennet Road and traverses east to the intersection of South 120th Street and Nebraska Highway 2, where it then continues east on Highway 2 until the intersection at South 148th Street;

WHEREAS, the Lincoln/Lancaster County Planning Director, based on the recommendation of the Nebraska Department of Transportation, has requested Street Name Change No. 19002 (“SNC19002”) regarding the following streets, as provided in Exhibit “A,” attached hereto and incorporated by this reference:

1. To rename a portion of Nebraska Highway 2 as Nebraska Parkway, between Calvert Street and S. 120th Street, Lincoln, Lancaster County, Nebraska, generally located on the existing Nebraska Highway 2 within the City limits of Lincoln (“City”) and the unincorporated area of the County, and

2. To name a proposed future connection as Jamaica Avenue, from the South Beltway to S. 27th Street;

WHEREAS, portions of the above-described roads (“Roads”) are found within the City limits, as well as outside the City limits and within the unincorporated area of the County;

WHEREAS, on February 4, 2020, the Board conducted a public hearing on SNC19002 with respect to the portions of the Roads outside of City limits and within the unincorporated area of the County; and

WHEREAS, on February 4, 2020, the Board voted to APPROVE SNC19002 with respect to the portions of the Roads outside of City limits and within the unincorporated area of the County;

WHEREAS, on February 10, 2020, the City Council voted to APPROVE SNC19002 with respect to the portions of the Roads within City limits;

NOW, THEREFORE, BE IT RESOLVED, by the Board, that SNC19002 with respect to the portions of the Roads outside of City limits and within the unincorporated area of the County, as provided in Exhibit “A,” is hereby approved, and shall be effective upon the opening of the South Beltway;

BE IT FURTHER RESOLVED, that the County will pay for the new name signs on the portions of the Roads outside the City limits and within the unincorporated area of the County; and






BE IT FURTHER RESOLVED, that upon approval of this Resolution, Lancaster County Resolution R-20-0010 is hereby rescinded.

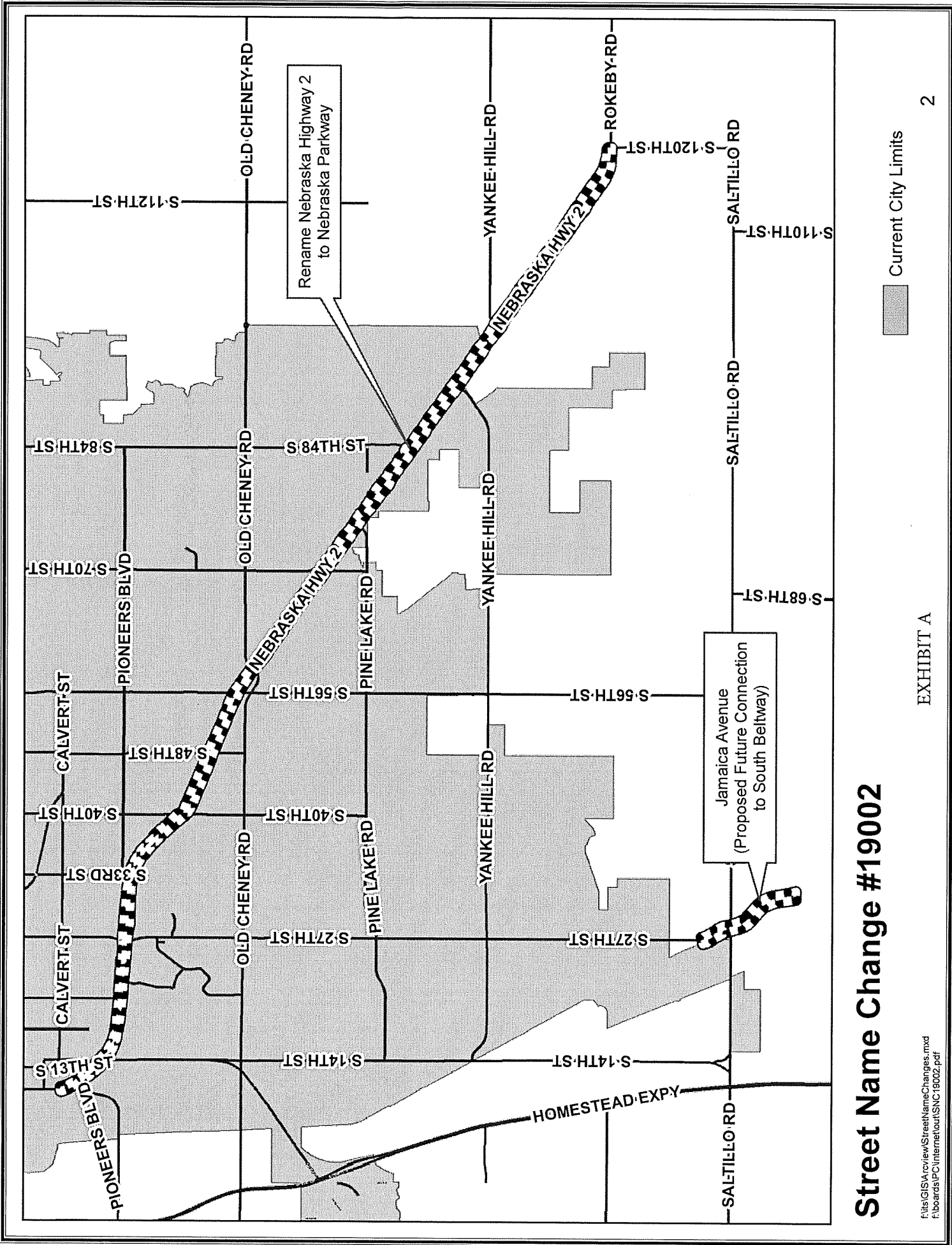
