FIREARMS PURCHASE PERMIT PROCEDURES

All Nebraskans have an important role to play in stopping the spread of COVID-19 and saving lives. To ensure the welfare of the public and our employees, we have three options for submitting your firearm purchase permit application. We are continuing to encourage applications to be printed and mailed in.

Instructions for submitting an application are as follows:

U.S. Mail:

1. You must be a Lancaster County Resident.
2. You must be 21 years of age or older to submit an application.
3. Carefully read and complete the application. If there are any questions that do not apply to you please place a N/A in the box.
4. The application must be signed in the presence of a notary and notarized on the second page of the application.
5. Include a phone number at the top of the application.
6. Include a photocopy of a valid Nebraska ID or Nebraska Driver's License with your current address OR if applicable, your citizenship papers, U.S. Passport, or alien resident card if you ARE NOT a U.S. citizen.
7. Mail the completed application with \$5.00 payment (cash/check/money order) to:

Drop-off:

1. Print your application and complete it (DO NOT SIGN) prior to arriving at the Lancaster County Sheriff's Office.
2. You must be a Lancaster County Resident.
3. You must be 21 years of age or older to submit an application.
4. Carefully read and complete the application. If there are any questions that do not apply to you please place a N/A in the box.
5. Include a phone number at the top of the application.
6. Bring a photocopy of a valid Nebraska ID or Nebraska Driver's License with your current address OR if applicable, your citizenship papers, U.S. Passport, or alien resident card if you ARE NOT a U.S. citizen.
7. Pay a \$5.00 fee by cash or credit card.
8. Sign the application in front of a Lancaster County Sheriff's Office clerk.

Walk-in (see hours below):

1. You must be a Lancaster County Resident.
2. You must be 21 years of age or older to submit an application.
3. Pay a \$5.00 fee by cash or credit card.
4. Bring a valid Nebraska ID or Nebraska Driver's License with your current address OR if applicable, your citizenship papers, U.S. Passport, or alien resident card if you ARE NOT a U.S. citizen.


Walk-in applications will ONLY be accepted Monday-Friday 8:30am to 11:30am in order to provide the best customer service possible.

Firearms purchase certificates will be sent out via U.S. mail and it can take up to 30 days to receive your certificate.

If you receive a denial letter in the mail, you may appeal or reapply using the steps above.
