AUTHORIZING THE INSTALLATION)
OF TRAFFIC CONTROL DEVICES IN) RESOLUTION NO. R-20-0065
LANCASTER COUNTY)

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that Lancaster County (“County”) shall place and maintain such traffic control devices upon highways within its jurisdiction to carry out the provisions of the Nebraska Rules of the Road or to regulate, warn, or guide traffic;

WHEREAS, NEB. REV. STAT. § 60-670 provides that traffic control devices include any sign, signal, marking, or other device not inconsistent with the Nebraska Rules of the Road placed or erected by authority of the County for the purpose of regulating, warning, or guiding traffic;

WHEREAS, the Lancaster County Engineer (“Engineer”) in the Engineer’s capacity as County Highway Superintendent, has control, government, and supervision of all the public roads and bridges in the County under the general supervision and control of the County Board of County Commissioners (“Board”) pursuant to Neb. Rev. Stat. § 39-1507;

WHEREAS, due to the results of a speed study conducted at the request of the City of Hickman, the Engineer recommends making changes to signs on Hickman Road between Hickman’s east city limit and S. 82nd St.;

WHEREAS, the Engineer has informed the Board that it is in the best interest of the traveling public to take the following actions with respect to traffic control devices in the County, at the following more particularly described locations (See Exhibit 1):


1. Replace the existing eastbound 55 M.P.H. sign (R2-1) approximately 200’ east of Terrace View Dr with a new 45 M.P.H. sign (R2-1).
2. Install a westbound 45 M.P.H. sign (R2-1) approximately 200’ west of S 82nd St.

3. Install a westbound "Reduced Speed Ahead" 45 M.P.H. Sign (W3-5) approximately 150' east of S 82nd St.
4. Install an eastbound 55 M.P.H. sign (R2-1) approximately 200' east of S 82nd St.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to the Lancaster County Engineer to take action with respect to traffic control devices as described herein.




