RESOLUTION NO. R-08-0051

WHEREAS, Neb. Rev. Stat. §53-124.11 (2007 Supp) provides in relevant part that:

Special designated license; issuance; procedure; fee. (1) The commission may issue a special designated license for sale or consumption of alcoholic liquor at a designated location to a retail licensee, a craft brewery licensee, a microdistillery licensee, a farm winery licensee, a municipal corporation, a fine arts museum incorporated as a nonprofit corporation, a religious nonprofit corporation which has been exempted from the payment of federal income taxes, a political organization which has been exempted from the payment of federal income taxes, or any other nonprofit corporation the purpose of which is fraternal, charitable, or public service and which has been exempted from the payment of federal income taxes, under conditions specified in this section;

and

WHEREAS, no special designated license provided for in Neb. Rev. Stat. §53-124.11 shall be issued by the commission without the approval of the local governing body; and

WHEREAS, Neb. Rev. Stat. §53-124.11 (6) authorizes a county to require the payment of a fee or tax by licensees to the county as a condition of delivery of the special designated licensee; and

WHEREAS, the County of Lancaster desires to impose a fee upon special designated licenses in order to recoup some of the expenses incurred in conjunction with the approval of said license.

NOW THEREFORE, BE IT RESOLVED by the County Commissioners of Lancaster County, Nebraska, that:

1. A \$80.00 fee is hereby imposed upon the aforementioned licensee to be paid to

the Lancaster County Clerk prior to the delivery of the special designated license by the Clerk;



2. Upon receipt of said fees, the Clerk shall deposit them with the County Treasurer for placement in the County's General Fund;
3. This Resolution shall be in full force and effect from the date of its execution by the Lancaster County Board;
4. Upon the execution of this Resolution, Lancaster County Resolution No. 00-147 and all other Resolutions and parts of Resolutions in conflict herewith, are hereby repealed.
